SHEER DRAMA rated three wide early and off of a hard to rate leader, steadily progressed leaving the far turn, challenged in hand between foes heading towards the stretch, spurted clear when set down past the quarter pole, kept on under strong rousing in mid stretch and proved clearly best. SOUTH ANDROS, unhurried early, angled out around the turn, advanced four wide into the stretch to loom a major presence, could not match strides with the winner but continued on gamely. MADE UP settled well off the early pace, came four wide for the drive and had a mild response. TABLE THREE TEN saved ground under rating, moved in tandem and inside of the winner around the turn, challenged into the stretch, gave chase past the eighth pole then faded. C C GOLD rated back between rivals early, dropped in to save ground, came under pressure chasing into the stretch, failed to sustain and weakened. BRENDA'S WAY bobbed at the break, regrouped to clear then got out badly while opening up, raced in about the eight path into the turn, was held in by her rider's firm left grip, wandered back out once collared into the lane then faltered. SPEEDY FIRST (KOR) gave early chase between runners, faltered around the turn, began being eased in upper stretch, was pulled up inside the sixteenth marker and walked off.
