IN THE FAIRWAY pressured the early leader off the rail, took over past the quarter pole, dueled clear nearing the top of the lane, drifted outward while extending his lead in the upper stretch then held on well under steady handling. HIDDEN CANYON stumbled leaving the gate, briefly settled into stride before picking up the chase off the rail, closed to the heels of a trio of rivals approaching the turn, eased to the four path into the lane, closed with a late rush and was gaining on the winner. GREY TIGER was hustled clear to set a pressured pace inside, caught past the quarter pole, checked when moving out a path nearing the head of the lane, and dug in to resume the chase into the lane, but leveled off toward the wire. MY JORDAN gave close chase about the four path to the head of the lane before flattening stride. ROY'S SONG chased the pace inside to the top of the stretch before leveling off. MR. RIPKEN, well back off the rail, eased out leaving the turn then shut off approaching the sixteenth pole. SATURDAYNIGHTFIGHT chased the pace widest, veered in through the upper stretch, made sharp contact with Lyle approaching the sixteenth pole and was not encouraged further. LYLE gave chase about the four path then bumped inward and into I Told You nearing the sixteenth pole. I TOLD YOU gave chase about the three path, angled toward the rail into the lane, then bumped and checked a sixteenth away. The stewards reviewed a claim of foul against the winning rider, lodged by the rider of Grey Tiger and took no action. They also posted the inquiry and disqualified Saturdaynightfght to last place for veering sharply in and causing a cascade effect involving Lyle and I Told You midstretch.
