1 1/8 MILES. (Turf) (1.394) STAKES. Purse \$175,000 *AMERICAN TURF S. (GRADE II) FOR THREE-YEAR-OLDS*. By subscription of \$175 each, which should accompany the nomination. \$875 to pass the entry box; \$875 additional to start, with \$175,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over on the turf allowed 2 lbs.; \$45,000 at a mile or over since October 9, 4 lbs.; two races at a mile or over other than maiden or claiming, 6 lbs. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). Closed Wednesday, April 7, 2010 with 46 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One and One Sixteenth mile.) (Clear 76)

Bay Colt, (Feb), by Rock Hard Ten - Serena's Sister by Rahy. Trainer Pletcher A. Todd. Bred by Arthur I. Appleton(FL).

DOUBLES PARTNER reserved early, advanced inside on the second turn, angled out for the drive, drew clear in midstretch and stayed clear while under steady urging. ASPHALT outrun early, made a good middle move while off the rail, angled out to follow the winner and finished willingly to be up for the place. GUYS REWARD stumbled at the start, was outrun for six furlongs, swung to the outside for the drive and closed well. SETSUKO reserved along the inside made a run on the rail leaving the second turn, split rivals in midstretch and improved his position late. WORKIN FOR HOPS lost his footing at the start, was reserved three wide, advanced four wide out of the second turn, reached a striking position with a furlong to go but weakened. GLEAM OF HOPE outrun for five furlongs, raced in the four path on the second turn and made a mild late gain. SAINT ELIGIUS behind the leaders off the inside, lacked a rally. STRIKE THE TIGER pressed the pace three wide, tracked the leader on the backstretch while taken well out in the course, angled back in to the three path for the second turn, held on well to the final furlong and tired. LOST APTITUDE set the pace off the rail, moved well out in the course on the backstretch, angled back to the two path for the second turn, held on well to the final quarter and tired.
