LA TIA broke sharply, moved to the rail dictating terms to her rivals on a comfortable margin under rating racing into the backstretch, continued in that fashion to the second bend, responded when prompted to go clear racing into upper stretch and steadily widened her margin to the end under firm handling. FRIVOLOUS angled to the inside early stalking just off the pacesetter under light reserve racing into the backstretch, was urged to advance racing into upper stretch while losing some position to the eventual winner, then shifted outside a drifting rival in the closing stages to narrowly prevail for the place honors on the wire. AWESOME FLOWER was urged to gain terms with the leader attending that rivals' pace in the opening stages, was urged to prompt that foe racing into the far turn, couldn't match the leader racing into upper stretch, then drifted inwards under pressure late while just missing for second. AMBUSHER tracked off the second flight along the inside under light rating racing into the backstretch, shifted out three wide racing into upper stretch and continued willingly in that path to gain some position while just missing for a share.
