CLOSE HATCHES away well, got clear in the two path into and through the first turn, rated in the run up the backstretch, called on for some run turning for home, held sway through the lane while under steady handling. ON FIRE BABY broke alertly, used slightly, closest to the winner off the inside, asked midway on the second turn, could make little progress on the winner the final furlong while proving determined for the place. STANWYCK fell far back to trail after the start, continued back the middle half mile, moved up closer five wide turning for home, flattened out. LET FAITH ARISE allowed the pace to go while racing outside, three wide through the first turn, moved a bit closer while continuing in the three path second turn, lacked further bid to come up empty in the late going. ROSE TO GOLD forwardly placed along the inside, a bit keen onto the backstretch, maintained contact with the winner into the far turn, began to fade soon after.
