Supplementary nominations may be made by Friday, April 3 at \$500. \$600,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. Weights to be announced Saturday, April 4. In Handicap Stakes starting preference will be given to high weights. Starters to be named through the entry box by the usual time of closing. UNTAPABLE broke in, brushed, off the pace while a bit keen in the first turn, moved out to be four wide onto the backstretch, stalked the issue up the backstretch while remaining outside, ranged up to challenge four wide midway on the second turn, took over, edged clear when straightened for home, maintained a daylight advantage to the wire under a firm hand ride. DIVA'S DIAMOND three wide and off the pace, settled in the run up the backstretch, moved a bit closer in the second turn, steered out four wide late in the final bend, set down, finished willingly to earn the place while not a serious threat to the winner. GOLD MEDAL DANCER away in good order, in hand and three wide off the pace, remained within striking distance into the far turn, shuffled back slightly when the winner ranged up outside three furlongs out, continued in the three path into the lane, mild finish to miss the place. PEARL TURN chased the leader early, continued to pressure that rival the middle half mile, gained a brief lead midway on the final turn, failed to sustain that momentum in the drive. CALL PAT bothered slightly at the start when the winner broke in, raced back, floated out four wide turning for home, failed to muster a late kick. GLORYS LAST CHANCE fell back to trail after the start, trailed most of the way, was never a factor. SUGAR SHOCK took over past the wire the first time, set the pace toward the inside, gave way when headed in the second turn.
