ZA APPROVAL reserved racing along the inside, angled five wide on the far turn, rallied to take over nearing the eighth pole and opened a clear lead, then was fully extended to hold **BEAU CHOIX** safe. The latter, unhurried into the far turn, swung wide for the stretch run and closed well for the place. **KING KREESEA** set the pace along the rail into the stretch, then weakened. **COOL BLUE RED HOT** allowed to settle, angled six wide on the far turn and advanced to reach contention in midstretch, then gave way. **SILVER MAX** well placed racing off the rail, tired in the drive. **EL COMMODORE** tracked the leaders into the far turn and faltered. **OMAYAD (CHI)** off slowly, was outrun. **JOES BLAZING AARON** stalked the pace four wide to the top of the stretch, then faded. **DECISIVE MOMENT** chased the pace off the rail to the quarter pole, then had nothing left. **OFF THE JAK** chased the pace three wide to midway of the far turn, then dropped back.
