1 MILE. (1.33²) STAKES. Purse \$150,000 ARLINGTON-WASHINGTON FUTURITY (GRADE III) FOR TWO-YEAR-OLDS. By subscription of \$150 each horse, which should accompany the nomination. A Supplementary Nomination of \$6,000 may be made on Wednesday, September 2, 2009, which includes entry and starting fees. Original nominees to pay \$1,000 to pass the entry box and an additional \$1,000 to start, with \$150,000 Guaranteed; after payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. WEIGHT: 122 lbs.; Fillies, 119 lbs. Non-winners of \$50,000 once, allowed 3 lbs.; \$35,000 once or a race other than Maiden or Claiming, 5 lbs. This event will not be divided; the field will be limited to fourteen (14) starters. Preference will be to winners of Graded/Group Stakes (in order of I-II-III); next preference, Highest Lifetime Earnings. Failure to draw into this race at time of entry cancels all fees with the exception of the nominating fee(s). Starters to be named through the entry box by usual time of closing. Trophy to the owner of the winner. Nominations Closed Wednesday, August 26, 2009 with 16. (Clear 72)

DIXIE BAND broke sharply, was handled well off the rail and brushed by **U APPEAL TO ME** in the stretch, got the lead late and stayed on. **U APPEAL TO ME** was never far back, took the lead mid stretch, lugged out late, brushed the winner but saved the place. **PISCITELLI** was unhurried early, swung wide in the turn then closed the gap late. **OAK MOTTE** raced evenly inside and lacked a late response. **BEWARE THE TIGER** set a pressured pace, led to mid stretch and faltered inside. **KRATISTO** was through early, trailed to the stretch and was no threat. **HERECOMESBERT** was void of early speed and outrun.
