Non-winners of a Grade I or Grade II race at One Mile or Over since August 1, 2013, allowed 3 lbs.; Non-winners of a Grade I or Grade II race at One Mile or Over OR Two Grade III races at One Mile or Over since February 1, 2013, allowed 5 lbs. WINNING PRIZE (ARG) stalked outside a rival then a bit off the rail to the stretch, bid alongside the pacesetter in midstretch, gained the advantage in deep stretch and gamely prevailed under urging. TOM'S TRIBUTE a bit slow to begin, pulled between horses then angled in nearing the first turn, came a bit off the rail into the backstretch, went outside a rival nearing and on the second turn, came out some in the stretch and finished well to gain the place late. REGALLY READY sped to the early lead, set the pace a bit off the rail, fought back toward the inside when challenged in the stretch, could not match the winner late and just lost the place. UNBRIDLED'S NOTE saved ground chasing the pace throughout and was outfinished for a minor award. SUGGESTIVE BOY (ARG) chased outside a rival or off the rail, went three deep into and on the second turn and into the stretch and lacked the needed rally. NO JET LAG broke slowly, angled in and saved ground off the pace, came out into the stretch and could not offer the necessary late kick. PROCUREMENT came out some early, chased outside a rival then a bit off the rail, came out in the stretch and also lacked the needed response in the drive.
