(GRADE III) FOR THREE-YEAR-OLDS AND UPWARD.* By subscription of \$100 each, which should accompany the nomination. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% of the added monies to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three year olds, 118 lbs. Older, 124 lbs. Non-winners of a Grade I or II stakes since November 6, allowed 2 lbs.; \$60,000 in 2010, 4 lbs.; three races other than maiden or claiming since October 31, 6 lbs. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. Closed Saturday, May 15, 2010 with 19 nominations. (Hazy 87)

RILEY TUCKER within striking distance while reserved and off the rail, advanced late on the turn, moved to the inside once in the stretch, caught the runner up inside the final furlong and slowly drew clear. ATTA BOY ROY lost his footing after breaking a bit in the air, quickly reeled in CHIEF OF AFFAIRS in the initial furlong without being asked, relaxed to allow that rival the lead to the quarter mile marker, drifted in changing leads in upper stretch when moving to challenge, took over with a furlong to go, could not cope with the winner late but held on gamely to be second best. CASH REFUND behind the leaders four wide, maintained good position to the final furlong and lacked a solid closing bid. CHIEF OF AFFAIRS set the pace off the inside, battled to the final furlong and tired. CASSOULET broke a bit in the air, recovered to race within striking distance in the three path, stayed on well to the stretch and tired. LISSA'S STAR was outrun while off the inside.
