MUCHO MACHO MAN stalked outside, went four wide leaving the backstretch, bid three deep on the second turn to take the lead into the stretch, kicked clear and proved best under some urging and steady handling. PAYNTER angled in and chased inside then a bit off the rail, went outside a rival on the second turn, came five wide into the stretch and gained the place. SOI PHET stalked off the rail then between horses, bid nearing the second turn then stalked again, angled out four wide into the stretch and came back late for the show. GOLDEN TICKET saved ground chasing the pace, swung three wide into the stretch and was outfinished for third. CHIEF HAVOC close up stalking the pace off the rail, bid between horses and took a short lead into the second turn, fought back between foes on that turn and weakened in the stretch. LIAISON came off the rail early, chased just off the fence then outside a rival, came out into the stretch and lacked the needed rally. SUMMER HIT sent between foes early, angled in and set the pace inside, dueled into and on the second turn, continued inside in the stretch and weakened. YOU KNOW I KNOW unhurried off the rail early, went outside a rival on the second turn, came out some in the stretch and did not rally. JERANIMO allowed to settle just off the rail then inside, lagged back to the stretch, came out in upper stretch and was not a threat. TAKE CONTROL angled in and chased inside then a bit off the rail, continued inside on the second turn and into the stretch and weakened.
