**6 FURLONGS. (1.072) STAKES. Purse \$100,000 BASHFORD MANOR S. (GRADE III) FOR TWO YEAR OLDS.** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$3,000 at time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Colts and Geldings 122 lbs. Fillies 119 lbs. Non-winners of a race other than maiden or claiming, allowed 2 lbs.; a race other than claiming, 4 lbs. The maximum number of starters for the Bashford Manor will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to highweight horses with consideration to the sex allowance. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Saturday, June 15, 2013 with 14 nominations. (Rainy 79)

**Dark Bay or Brown Colt, (Mar), by Discreet Cat - Top Marks by Marquetry. Trainer Robb J. John. Bred by Brandywine Farm (KY).**  
DEBT CEILING tracked three wide, made a sweeping move into the teeth of rapid fractions through the turn, quickly opened clear, was kept to task and held sway. HOLLYWOOD TALENT prompted the pace to the outside of MY CORINTHIAN to the turn, dropped off of the pace three wide, came again entering the stretch, angled to the inside of DEBT CEILING but was unable to bridge the gap. MY CORINTHIAN rushed to the lead along the inside, carved out a fast pace, was no match for the winner leaving the turn, weakened further in the drive and settled for the minor award. RUNKLE was allowed to settle, came four wide and improved position between horses. D'CAJUN CAT contended three wide but lacked a response when called upon. GUN ROAR broke a bit slow, settled saving ground and was never a factor. SANDBAR broke sharp, stumbled just after the start, settled in hand five wide but showed little thereafter.
