UZZIEL was quickest of all early and sped to uncontested lead, retained command while in hand around the turn, dug in when challenged in upper stretch and held sway under right hand urging despite lugging out late. RAMONA'S WILDCAT bumped at the start, tracked pacesetter from off the rail, mildly roused and moved up on the turn, challenged outside pacesetter in upper stretch but was turned back and held for second. MISS SUPER QUICK chased while outside rival then between rivals, remained on two wide path into the stretch and held third despite drifting out late. CLASSY AVA stalked while outside foe then three wide on the turn, came out further leaving the bend and failed to threaten. MON PETITE angled over early, chased while two then three wide to the stretch and failed to reach contention. SPRAGUE RIVER broke in and bumped rival, also shifted over some, saved ground chasing the pace, swung back out four wide and was outrun. DELTA FLOWER was close up early from the inside, continued to hug the rail into the stretch and weakened.
