gamely under left handed urging. WILL TAKE CHARGE came off the rail in the stretch the first time, stalked outside a rival, bid three deep into the second turn, continued outside a foe then off the rail in the stretch and went on willingly but could not catch the winner. BLINGO chased inside then a bit off the rail, went outside a rival on the second turn and three deep into the stretch and gained the show late. MUCHO MACHO MAN had some early speed inside then stalked a bit off the rail, bid between horses into the second turn, continued just off the inside leaving that turn and weakened in the stretch. HEAR THE GHOST pulled his way along and angled in, dueled outside the winner, drifted out into the

first turn, stalked off the rail then inside on the backstretch, dropped back between foes leaving the second turn and also weakened. ROUSING SERMON allowed to settle a bit off the rail, came out into the stretch and lacked the needed rally. IMPERATIVE pulled early and angled in, saved ground chasing the pace, continued inside on the second turn and did not rally. AMERICÁN BLEND broke a bit slowly, settled outside a rival then three deep leaving the backstretch, fell back off the rail on the second turn and had little left for the stretch.
