HEAR YE HEAR YE pressed the pace, moved to take over at the quarter pole, made the pace to the top of the stretch, then tired. SOUTHERN REVIEW set the pace under pressure along the inside to the quarter pole, then faltered. TURNAROUND was outrun after breaking slowly.
