ROYAL DELTA settled nicely in the clear and off of a contested early pace, gained quickly along the rail leaving the three eighths pole, angled out and launched her bid nearing the quarter pole, forged clear past the three sixteenths marker, drifted in towards the rail, responded to stout left handed pressure through the final sixteenth and held sway. BUSTER'S READY, fractious in the gate, broke inward and bumped with WYOMIA, was straightened away and moved up three wide into the first turn to gain a stalking position, was put to a solid ride leaving the far turn, continued on gamely through the drive and was clearly second best. HOT SUMMER grabbed command soon after the break, set solid fractions along the rail while under some rating, edged away when roused leaving the far turn, was confronted by the winner a quarter mile out, gave little resistance and tired through the final furlong. LOVE THEWAY YOUARE lagged far back, angled out in upper stretch and failed to threaten while showing belated interest. WYOMIA, bumped at the break, prompted the pace two wide, could not go on with HOT SUMMER past the three eighths pole then faltered approaching the stretch.
