About 5½ FURLONGS. (Turf) (1.024) STAKES. Purse \$60,000 *BONAPAW S. FOR THREE YEAR OLDS AND UPWARD*. No nomination fee. \$300 to enter and \$300 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$60,000 Guaranteed of which 60% to the winner; 20% to second; 10% to third; 4% to fourth; 2% to fifth and 1% to starters sixth through ninth. Weight: Three Year Olds - 122 lbs. Older - 124 lbs. Non-winners of \$45,000 on the turf since October 19,2009 allowed 2 lbs. \$30,000 on the turf since then allowed 4 lbs. \$25, 000 on the turf since September 19, 2009 allowed 6 lbs. (Maiden,claiming and starter races not considered in estimating allowances.) Starters to be named through the entry box by the usual time of closing. Preference to horses that have accumulated the highest total earnings on the turf in 2008-2009. Different owners have equal draw according to money earned. Second choice high earners of a same owner entry receive no consideration over a single entry. Failure to draw into the race will cancel all fees. The owner of the winner to receive a trophy. Closed Saturday, December 5, 2009, with 23 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at 5 and 1/2 Furlongs.) (Rail at 12 feet). (Clear 55)
