(GRADE II) FOR FILLIES, THREE YEAR OLDS.** By subscription of \$200 each by Saturday, March 14, 2009, which shall accompany the nomination, \$2,000 to pass the entry box and \$2,000 additional to start, with \$200,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$120,000, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to sixth. Supplemental nominations may be made on Sunday, March 22, 2009 at a fee of \$8,000, which includes entry and starting fees. Weight: 122 lbs. Non-winners of a grade/group I or II stakes allowed, 2 lbs.; of a sweepstakes, 4 lbs.; of two races other than maiden or claiming, 6 lbs.; of a race other than maiden or claiming, 8 lbs. The field will be limited to 14 Starters, with Also Eligibles. Starters to be named through the entry box by the usual time of closing. High Weights Preferred with second preference to horses with the highest lifetime earnings. Trophy to the winning owner. Nominations closed Saturday, March 14th, 2009 with 11 nominations. (Clear 77)

CASANOVA MOVE chased the pace three wide, made a run three wide with JUSTWHISTLEDIXIE to reach even terms for command leaving the far turn, contested the pace to the eighth pole, then couldn't stay with that rival while clearly second best. HOPEFUL IMAGE unhurried early, passed tired rivals for the show. SUZ SLEW steadied from tight quarters on the first turn and was not a factor. GATORETTE stumbled at the start, sprinted to a clear lead racing off the rail, made the pace to nearing the stretch, then tired. SHARED ACCOUNT reserved off the pace, faltered.
