About 1 1/8 MILES. (Turf) (1.42) STAKES. Purse \$75,000 **BUDDY DILIBERTO MEMORIAL H. FOR THREE YEAR OLDS AND UPWARD**. Free nomination by Saturday, December 7. \$400 to enter; \$400 additional to start. Supplemental nominations will be accepted by 12:00 noon, Thursday, December 12 at a fee of \$1,500, which shall include entry and starting fee s. \$75,000 Guaranteed of which 60% to the winner; 20% to second; 10% to third; 4% to fourth; 2% to fifth and 1% to finishers sixth through ninth. Weights to be announced Thursday, December 12. Starters to be named through the entry box by the usual time of closing. The maximum number of starters for the Buddy Diliberto Memorial Handicap will be determined by rail setting. High weights on the scale will be preferred. Failure to draw into the race cancels all fees. A trophy will be presented to the owner of the winner. Closed Saturday, December 7, 2013 with 42 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One Mile and One Sixteenth.) (Rail at 15 feet). (Cloudy 75)

DADDY NOSE BEST bumped with a rival at the start, saved ground on the first turn, settled well back in the field, was urged along while three then four wide on the far turn, swung six wide into the stretch, rallied on the outside, closed strongly to get the lead near the sixteenth-pole then drew clear and was eased up near the wire. **ADIOS NARDO** set the pace through quick fractions, came under a drive in upper stretch, remained clear into the final furlong, was collared near the sixteenth-pole and proved no match while clear for the place. **COMPLIANCE OFFICER** bumped with an opponent at the start, saved ground on the first turn, settled off the pace, was urged along while three wide on the far turn, came four wide into the stretch and narrowly earned the show. **PURE TACTICS** settled in the middle of the field, raced inside early on the far turn then came off the rail, shifted four wide into the stretch and lacked the needed response then just missed the show. **MR. VEGAS** settled while off the inside, was ridden along on the far turn, came three wide into the stretch and failed to rally. **KING DAVID** had a shoe repaired in the paddock, brushed with a rival after the start, lingered well back in the field, swung four wide into the stretch and failed to threaten. **STREET SERENADE** went three wide on the first turn, settled off the pace, was urged while two to three wide on the far turn and failed to respond. **WELLOILEDMACHINE** brushed with a rival after the start, went four wide on the first turn, settled off the pace, was urged along while three then four wide on the far turn, came five wide into the stretch and also failed to respond. **SKYRING** settled on the inside, continued to save ground while under urging on the far turn, was taken up at the quarter-pole and never reached contention. **MARCHMAN** went four wide on the first turn, tracked the pace on the outside, chased on the far turn and gave way. **DERBY KITTEN** lagged at the rear of the field and showed little. **HAMMERS TERROR** went three wide on the first turn, raced up close to the pace, came up empty while inside on the far turn and stopped. (Rail at 15 Feet)
