BENCH THE JUDGE had speed outside then dueled alongside a rival, took the lead into the stretch, inched away under urging and proved best. WOLF TAIL chased between horses then a bit off the rail, angled in on the turn, came out leaving the turn and three deep into the stretch and picked up the place. RUNAWAY BANDIDO between foes early, angled in and dueled inside, fought back on the turn and into the stretch and held third. REALLY UPTOWN pulled his way along inside to stalk the pace, came out leaving the turn and into the stretch and was edged for the show between horses. TRIBAL FACE chased between foes then four wide, continued outside a rival leaving the backstretch and on the turn, came out into the stretch and was outfinished for a minor award three deep on the line. SWISS EXPLOIT saved ground off the pace, continued inside on the turn and in the stretch and was not a threat. WARREN'S DOC GUS broke a bit slowly, settled inside, came out a bit into the stretch and did not rally. CHOCOLATE MARINI chased outside then off the rail, angled in alongside a rival on the turn and lacked a further response. SWISS ARROGANT stalked between horses then off the rail, dropped back on the turn, came four wide into the stretch and weakened.
