1 1/4 MILES. (Turf) (1.444) STAKES. Purse \$75,000 CALDER OAKS FOR FILLIES, THREE YEARS OLD. By subscription of \$75 each which shall accompany the nomination, \$750 to pass the entry box and an additional \$750 to start - with \$75,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a sweepstakes of \$75,000 at a mile or over allowed 3 lbs.; non-winners of a sweepstakes of \$ 50,000 at a mile or over, 5 lbs.; \$35,000 or non-winners of two races other than Maiden, Claiming or Starter at a mile or over, 7 lbs. Graded placed horses at equal weights preferred. Graded stakes winners preferred. A trophy will be presented to the winning Owner. Closed Saturday, October 3, 2009 with 14 nominations. (If deemed inadvisable to run this race over the Turf course, it will be run on the main track at One Mile and One Eighth). (Cloudy 80)

CHARY rated off the pace, swung out for the stretch run, rallied to gain the lead approaching the sixteenth pole and edged away. PROUD OSCEOLA stalked the pace along the hedge, altered course outside a wall of horses for room nearing the eighth pole, then closed to be up for the place. HOPEFUL IMAGE reserved while saving ground into the stretch, eased out and rallied to be up for the show. ONE PROUD LADY unhurried after breaking slowly, saved ground into the stretch and finished willingly while being edged for the show. ROYAL CARD chased the pace, moved up to engage FIRE WATER racing down the backstretch, moved to gain a slim lead on the far turn, made the pace to inside the eighth pole, then weakened. BOB'S JAWBREAKER failed to menace. PROVIDANZA (FR) stalked the pace three wide, made a run to try ROYAL CARD leaving the far turn and into the stretch, then tired in the final sixteenth. FIRE WATER sprinted to a clear lead along the hedge, responded when challenged on the backstretch, maintained a slim advantage into the far turn, then tired. SCORE BOYERA stalked the pace three wide to midway of the far turn, then faltered. ASIATIC PEARL was through after a half mile.
