WINEY TAYLOR showed speed along the hedge, drew well clear around the turn but couldn't match strides with the winner in the final sixteenth while holding the place. SWEET LIKE SUGAR chased the pace into the stretch and finished willingly for the show. CHECKITOFF unhurried after being pinched back at the start, swung out for the stretch run and closed with a belated rally. BIG CITY DIVA rated off the pace, saved ground into the stretch and closed with a mild response. PHONE MARYBE chased the pacesetter to midway of the turn, then gave way. CYNTHIA'SDREAM was not a factor. FULL OF GUT chased the pace three wide to midway of the turn, then tired. DREAMING PRAYERS well placed early, faltered. CAT FERRAD tracked the leaders to midway of the turn, then faded. BWANA EXPRESS off slowly, raced four wide and never threatened. CATS LIZ RULES showed little after stumbling at the start.
