By subscription of \$75 each, which shall accompany the nomination, \$500 to pass the entry box and an additional \$500 to start - with \$55,000 guaranteed and an additional \$20,000 from the FTBOA Stakes Fund monies will be corresp ondingly divided provided a Florida Bred Registered with the FTBOA and/or by a sire registered with the FTBOA and or by a FSS nominated sire has finished in an awarded position. CITIZEN ADVOCATE chased the pace outside EXCLUSIVELY MARIA, was forced wide by that rival at the top of the stretch, then rallied under pressure to be up late. SWEET AND VICIOUS chased the pace along the hedge, moved to gain a slim lead in early stretch when EXCLUSIVELY MARIA bore out, vied with that rival to deep stretch and yielded. EXCLUSIVELY MARIA showed speed along the inside, then bore out at the top of the stretch losing the lead, continued to press the pace outside SWEET AND VICIOUS to deep stretch and weakened. I'D LIE tracked the pace, made a run to loom a threat in midstretch but couldn't sustain her bid. LETS GO DONNA rated off the pace, raced three wide around the turn and had no response. MY TRULY FAIR chased the pace three wide around the turn and tired. PERFECT CASH failed to menace. WHO IS CAMILLE raced four wide and faltered. MISS MARTIN checked from close quarters in the early going and was outrun. ADELA'S SONG was not a factor. DENAESALILDREAMER saved ground and faded.
