COMPLIANCE OFFICER broke in at the start, was reserved while off the inside, went three wide on the far turn, came four wide into the stretch, rallied to the lead near the three-sixteenths pole and drew clear under good handling. BARYSHNIKOV stalked the leader on the outside, made a bid at the top of the stretch, battled into the final furlong and proved no match while clear for the place. QUICK DELIVERY settled in third while off the inside, was roused on the far turn and lacked the needed response while able to get the show. MONZANTE settled on the inside, came off the rail near the quarter-pole, moved out near the three-sixteenths pole, drifted out in the final furlong and failed to threaten. AVENSTOKE settled on the outside, was roused while three wide on the far turn and failed to respond. THABAZIMBI set the pace through moderate fractions, lost the lead inside the quarter-pole and gave way. DUCDUC dropped well behind the field, saved ground on the turns and trailed.
