TRIFECTA KING stalked outside a rival, bid three deep into the stretch, gained the lead outside foes nearing midstretch and won clear under steady handling. ATKA off a bit slowly, settled inside then just off the rail, came out in the stretch and picked up the place late. UPPER MANHATTAN pulled her way up to stalk the pace inside, waited off heels into the turn, continued inside, waited a bit again in midstretch, split rivals in deep stretch and bested the rest. CALL ALY dueled outside a rival, was between foes in upper stretch and weakened late. MAKASI settled outside chasing the pace, went three deep on the turn and into the stretch and lacked the needed rally. GOT TOBE RIO had good early speed and dueled inside to upper stretch and weakened. SHE'SMYLITTLEMAN settled off the rail, went outside on the turn and four wide into the stretch and did not rally. GONGING WILD stumbled at the start, went up between horses then chased inside to the stretch and weakened.
