After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights to be announced Friday, November 18, 2011. Starters to be named through the entry box by the usual time of closing. Trophy to winning owner. Closed Wednesday, November 9, 2011 with 25 nominations. (Clear 63)

WISE DAN tracked the pace three wide in hand, drew even with a quarter to run, wrestled control away a furlong out and gamely edged clear. MISSION IMPAZIBLE was close up two wide, forged a narrow lead leaving the second turn, kept on well but was unable to resist the winner. FLAT OUT settled in hand, shifted out four wide to commence his rally, ranged into striking distance but flattened during the drive. MISTER MARTI GRAS was allowed to settle, circled five wide and improved position through the lane. RULER ON ICE settled saving ground, moved up between horses on the second turn, offered a mild bid but failed to sustain the drive. HEADACHE broke a step slow, was unhurried into stride, worked his way to the outside in the upper stretch and finished with a belated gain. ALMA D'ORO made a middle move along the inside, got through entering the stretch but came up empty in the drive. WILL'S WILDCAT opened clear to set the pace, was collared after six furlong, stayed on to the stretch and tired. PRAYER FOR RELIEF attended the pace three wide through the second turn and faltered. STATELY VICTOR was forwardly placed along the inside to the second turn and dropped out. DEMARCATION was unhurried between rivals and failed to respond. PLEASANT PRINCE showed little. GENERAL QUARTERS was never a factor.
