ALSVID broke alertly despite stumbling, quickly recovered, stalked three wide, came in the four path out of the turn, set down, finished with good resolve to be up in time. IVAN FALLUNOVALOT closest to the leader off the inside, went after that rival and took over nearing the furlong marker under pressure, got clear, could not contain the winner, well clear of the rest. PICKO'S PRIDE quickly got clear after the start, set the pace off the inside, continued to show the way through the turn, weakened a bit, comfortably saved the show. DOUBLE OURS last away, trailed early, two path through the turn, improved into the lane, flattened out a bit in the drive. UNBRIDLED'S NOTE shuffled back at the start, raced well back, made little impact through the lane. BEST OF BIRDSTONE lacked speed off the inside, remained in the two path in the turn, some traffic mid turn, no threat in the drive. GENTLEMEN'S BET in mid pack for a half, gave way and had nothing for the drive.
