A HANDICAP FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD FOALING IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE REGISTRY.* No nomination fee. \$500 to pass the entry box and an additional \$500 to start. A supplemental nomination fee of \$2,000 in addition to the entry and starting fees will be accepted at any time prior to the publication of weights. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finisher. A presentation will be made to the winning owner. Nominations closed Saturday, May 18, 2013 with 20 Nominations and 1 Supplement. (Clear 84)

CLEAR PASAJ out broke BEAUTIFUL BUT NICE by a slight margin, raced on even terms with the same opponent before being conceded the advantage, showed a desire to come out while proceeding down the backstretch, pilot applying a strong grip on the left rein to counteract it, settled at a slight distance from off the rail for the start of the run around the bend and went about more professionally, arrived at the quarter pole and was called upon, drifted out chunks of real estate at intervals, both under her own volition and after having been given some sporadic left handed shots, dug in well in the late stages to reach the finish line in time. LADY ON THE RUN unhurried for the opening half, picked up the pace noticeably leaving the five-sixteenths marker, angled off the rail entering the stretch, altered course a couple of paths to the outside in midstretch, got herded out for a couple of jumps by BEAUTIFUL BUT NICE a sixteenth down the road, continued onward with good courage but fell short. BEAUTIFUL BUT BLUE went at it head to head with the top one in the very earliest stages, was put to a solid hold and taken back, tipped to be outside that foe almost immediately afterwards, gave chase towards the two path, failed to fully latch at any point, drifted out considerably after leaving the furlong marker and eventually weakened into the show slot. MISS VALENTINE off the inside, scurried into contention with a strong run unleashed from midway on the turn, flattened out. MISCHIEF MAKER chased the front runners three wide and under urging on the turn, gave way. GREAT GRACIE DANE in the four path, and the widest of all on the bend, folded.
