RULE went to the front, took command, saved ground around the final turn, dueled down the stretch with UH OH BANGO and prevailed for the win. UH OH BANGO pressed the pace, challenged the leader throughout, dueled down the home stretch, was outfinished for the win, but proved best of rest. OAK MOTTE unhurried in the early going, raced five wide around the first turn, moved up, within striking distance, made a late bid and proved third best. LITIGATION RISK raced near the middle of the field, eased back, came around the final turn four wide, made a mild bid after turning for home, but was no factor. GRAND SLAM ANDRE pressed the early pace and faded. MY TIME TO STAR lacked early speed and was never a threat. GALLANT GENT raced within contention and retreated. BENCH THE JUDGE always raced near the back and was outrun.
