BELLA DIAMANTE raced in the middle of the field, moved up, four wide around the final turn, made a bid, proved no match for the winner, but held on for second. JOANIE'S CATCH lacked early speed, made a late rally and missed second. BEST REWARD brushed at the start, racing in the back, made a late gain and was outfinished for third. DREWMAN PRINCE void of early speed, raced five wide around the final turn, moved up and finished evenly. LELA pressed the early pace and faded. WOMAN SOLDIER raced within contention and retreated. THE RUMOR'S TRUE brushed at the start, raced in the middle of the field, dropped back, finished wide and was no threat. TRUTH AND JUSTICE went to the front, took command, saved ground around the final turn, weakened, took a bad step at the head of the stretch and was pulled up.
