After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over allowed 2 lbs.; \$60,000 at a mile or over, 4 lbs.; two races other than maiden or claiming, 6 lbs. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. Closed Saturday, May 15, 2010 with 22 nominations. (Hazy 87)

TAP TAP TAPPING outrun for a half, commenced her rally near the rail late on the turn, angled out just inside the final furlong and closed well late. FUZZY BRITCHES reserved off the inside, stayed on well to the final furlong and lacked a closing bid. VERTICAL VISION outrun early, raced off the inside on the turn and improved her position while no threat. VISAIVIS bobbed after the start, forced the pace off the inside and tired. HELEN BELEN alternated for the lead along the inside and gave way in the drive. AGE OF HUMOR was no threat three wide. BELL'S SHOES within striking distance along the inside, faded.
