**6½ FURLONGS. (1:13<sup>3</sup>) STAKES.** Purse \$50,000 Don Bernhardt S.FOR THREE-YEAR-OLDS AND UPWARD. Free nomination, \$250 to pass the entry box and \$250 additional to start. Supplementary nominations may be made at time of entry by payment of \$2,500 (includes entry and starting fees). \$50,000 Guaranteed. The Association's money to be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: Three-Year-Olds, 120 lbs. Older, 124 lbs. Non-winners of \$45,000 twice in 2015 allowed 2 lbs., A sweepstakes in 2015, allowed 4 lbs., (Maiden, claiming and starter races not considered in allowances). Starters to be named through the entry box by the usual time of closing. The race will be limited to 12 starters. Highweights preferred. In the case of ties, second preference to start will be given to those horses having accumulated the highest earnings in 2015. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and the supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Nominations closed on Saturday, July 4, 2015 with 22 nominations. (Clear 92)
