CHIPS ALL IN stalked the pace outside, bid three deep into the stretch, battled alongside a rival then took a short lead in deep stretch and held on gamely under left handed urging. BOAT TRIP settled a bit off the rail to the stretch, came out in upper stretch and closed willingly to get up outside for second. UNBRIDLED'S NOTE chased between horses then a bit off the rail, came out in the stretch and rallied between foes late. CARACORTADO settled a bit off the rail then came out on the hill, was in tight nearing the dirt and four wide into the stretch and finished with interest. SNOWDAY (FR) stalked off the rail, bid between horses into the stretch, took a short lead, fought back inside in the drive and was unfinished late, then did not return to be unsaddled when bleeding from the nostrils and was vanned off. EL MIRAGE KING broke alertly then dropped back outside, went four wide on the hill and into the stretch, was in a bit tight between foes past midstretch and was unfinished. ROCK ME BABY stalked between horses, was in tight past the eighth pole and boxed in off heels through the final sixteenth. ET TU WALKER stalked the pace inside, continued along the rail in the stretch and lacked the needed late kick. ROSENGOLD had good early speed off the rail then inched away and angled in, set the pace inside, dueled along the rail into the stretch and weakened in the final furlong. HUNTSVILLE a bit slow to begin, settled just off the rail, came out leaving the hill and four wide into the stretch and was not a threat. SIROCCO STRIKE chased outside then three wide between horses on the hill and into the stretch and weakened. MAJESTIC CITY angled in and settled a bit off the rail when unhurried down the hill, came out into the stretch, drifted to the far outside in the drive and was eased in the lane. A claim of foul by the rider of ROCK ME BABY against EL MIRAGE KING for alleged interference in the stretch was not allowed by the stewards, who ruled the latter was not the cause of the trouble to the former. Rail on hill at zero.
