Closed with 17. \$700 additional to start, with \$70,000 added. The added monies and all fees to be divided 60% to the winner, 20% to second, 12% to third, 6% to fourth and 2% to fifth. 122 lbs. Non winners of a sweepstakes at one mile or over allowed 2 lbs.; Non-winners two races other than claiming at one mile or over, 4 lbs.; a race other than maiden or claiming, 6 lbs. Horses with the highest earnings at time of entry have preference after allowances. (Clear 60)

FLASHMANS PAPERS (GB) stalked the pace off the rail to the stretch, inherited the advantage in upper stretch and held on gamely under urging. KELLY LEAK angled in and settled outside a rival, advanced outside on the second turn and four wide into the stretch and finished well but could not get by the winner. CONGOR BAY bobbed at the start, pulled his way along and angled in early, chased inside, came out into the stretch and just held third. OIL MAN (IRE) settled inside, came out on the second turn and three deep into the stretch and put in a late bid. MIGUEL'S MASCOT saved ground chasing the pace, steadied at the spill in upper stretch, went around a fallen foe and put in a late bid at a minor award inside. TIZ TRUE chased outside a rival then between horses on the second turn and did not rally. SCORPIO DOG off a bit slowly, stalked outside a rival of just off the rail, came three deep into the stretch and weakened. BACK AT YOU pulled his way to the early lead, set all the pace inside, opened up on the backstretch, continued clear into the stretch, ducked into the rail in upper stretch, lost the rider and fell, then was vanned off. The stewards conducted an inquiry into the incident in the stretch but made no change when they ruled BACK AT YOU was responsible for his own trouble.
