PROMISE ME SILVER attended the pace along the inside, shifted out to commence her bid on the turn, was carried out further entering the stretch, struck the front with three-sixteenths to run, opened clear and maintained a safe advantage. CALLBACK settled saving ground, moved with the winner through the turn, angled to the outside leaving the turn, was carried out in the upper stretch, was unable to match strides with the winner then was all out hold the place. SCAT MEANS GO was unhurried into stride, swung seven wide and was making up ground. MIZZ MONEY was bumped at the start, settled saving ground, split horses leaving the turn and improved position through the lane. SUPER SAKS set the pressured pace three wide, opened clear on the turn, was collared near the quarter pole, drifted out entering the stretch and weakened. TAYLOR S was allowed to settle five wide, tucked in a bit on the turn, was caught in tight between horses and steadied near the five-sixteenths pole, tipped back out entering the stretch but went evenly. STREETHEART stalked the pace four wide, loomed a danger entering the stretch but weakened between rivals. LAVENDER CHRISSIE was allowed to settle four wide and lacked a response when called upon. ENCHANTING LADY was unhurried into stride, went wide and showed little in a dull effort. FANCY AND FLASHY broke slow and was bumped at the start, rushed up between horses, but came up empty after a half and dropped out. EKATI'S PHAETON vied for the lead along the inside, but bled and stopped after a half.
