1 1/2 MILES. (1.452) STAKES. Purse \$250,000 *EMPIRE CLASSIC S. FOR THREE YEAR OLDS AND UPWARD FOALING IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY.* No nomination fee. A supplemental nomination fee of \$2,500 may be paid at time of entry. \$2,500 to pass the entry box. All starters including supplementers are required to pay all fees and will receive a \$1,250 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds 121 lbs. Older 124 lbs. Non-winners of \$60,000 or \$40,000 twice at a mile or over in 2009 allowed 2 lbs.; a sweepstake at a mile or over in 2009, 4 lbs.; four races, 6 lbs. (Maiden, claiming, starter and restricted allowance races not considered in allowances). A trophy will be presented to the winning owner. Closed Saturday, October 10, 2009 with 25 Nominations. HAYNESFIELD rushed up inside, led to the turn, shook loose and was fully extended to hold on in the late stages. RUFFINO raced up close from outside for a half, lodged a bid on the turn and finished willingly to gain the place. UNDOCUMENTED was outrun for a half, swung wide and rallied belatedly. DR. D. F. C. saved ground to the turn and rallied mildly. NAUGHTY NEW YORKER saved ground on the turn, swung out and closed mildly. SLEVIN gained four wide on the turn and flattened out. WEATHERED saved ground just off the pace into midstretch and tired. PLATINUM COUPLE failed to mount a serious rally. TYPHOON TYCOON staided in traffic on the backstretch and failed to threaten thereafter. FUTURE PROSPECT raced up close between horses and faded. LOVE ABROAD was used up dueling early and eased late.
