Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$60,000 Guaranteed of which 60% to the winner; 20% to second; 10% to third; 4% to fourth; 2% to fifth and 1% to starters sixth through ninth. Weight: Three Year Olds - 122 lbs. Older - 124 lbs. Non-winners of \$45,000 since October 19, 2009 allowed 2 lbs. \$30,000 since then allowed 4 lbs. \$25,000s ince September 19, 2009 allowed 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances.) Starters to be named through the entry box by the usual time of closing. Preference to horses that have accumulated the highest total earnings in 2008-2009. Different owners have equal draw according to money earned. Second choice high earners of a same owner entry receive no consideration over a single entry. Failure to draw into the race will cancel all fees. The owner of the winner to receive a trophy. Closed Saturday, December 5, 2009, with 20 nominations. (Clear 55)

MY CRIMSON CAT forwardly placed off the rail, weakened. SOUTHERN YANKEE came in at the break forcing in NORTHERN BELLE, then was outrun. SUMTHINGTALKABT brushed at the break, recovered to move up early, then faltered down the lane. OVERANDABEAUTY was never dangerous. HOTLANTIC showed little.
