FOR TWO YEAR OLDS.* By subscription of \$75 each, which shall accompany the nomination, \$500 to pass the entry box and an additional \$500 to start - with \$55,000 guaranteed and an additional \$20,000 from the FTBOA Stakes Fund monies will be correspondingly divided provided a Florida Bred Registered with the FTBOA and/or by a sire registered with the FTBOA and or by a FSS nominated sire has finished in an awarded position. Any FTBOA Stakes fund monies not awarded will revert back to the fund. The Owner of the winner to receive 60%, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 122 lbs. BOYFRIEND'S BACK outrun after breaking a step slowly, swung wide for the stretch run and passed tired rivals to gain the show. **CATHY'S IRISH BOY** saved ground and failed to menace. **MILE HIGH CITY** stalked the pace three wide around the turn, then tired. **CELTICS STRIDE** off slowly, was never a factor. **FULL MOON'S BACK** rated off the pace after breaking a step slowly, raced three wide around the turn and faltered. **LAW DOG** vied for the lead along the rail to midway of the turn, then faded. **BANZAI KID** vied for the lead outside **LAW DOG** to nearing the stretch, then had nothing left.
