SILVER MAX opened clear and angled in to set the pace near the hedge, drifted out a bit entering the stretch but continued on doggedly to hold sway. NIKKI'S SANDCASTLE was close up three wide, tipped out five wide entering the stretch, kicked on well and was all out to earn the place. GUYS REWARD was unhurried along the inside, shifted out four wide leaving the second turn, rallied between horses and was up in time to earn the show. VILLANDRY was allowed to settle, wheeled out five wide entering the stretch, was floated out further but kept on and was making up ground. FREE WORLD was forwardly placed along the inside, got through entering the stretch to make his bid but weakened during the drive. VALENTINO BEAUTY settled saving ground but lacked a response when called upon. REGALLY READY pulled to contention four wide, was close up to the stretch, but was collared between horses and gave way readily. JOHA was allowed to settle four wide and was never a factor.
