LESS THAN PERFECT pressed the pace to the quarter pole, assumed command turn at the head of the stretch and drew clear through the lane. BOURBON COWBOY stalked the pace from a clear pocket through the turn, angled out to challenge in upper stretch, loomed boldly and was no match for the winner. DRAW NIGH allowed to settle at the rear of the field, steadily gained ground through the lane to be up for the show. BREAKIN THE FEVER rushed up the inside to take the lead entering the main track, was under steady pressure from the winner and weakened through the stretch. MACHINATION tracked the leaders to the turn, was set to an early drive and lacked a response when called upon. DUFF saved ground while well position through the turn and failed to rally.. COOPER'S CRESCENT went evenly while racing wide. COURT'S RULING prominently placed early, dropped back through the turn as no factor. SERAPH refused at the break and walked off the track.
