FOR FOUR YEAR OLDS AND UPWARD FILLIES AND MARES REGISTERED FLORIDA BREDS WITH THE FTBOA.* Free nomination by Saturday, January 14, 2012, \$1,500 to pass the entry box and \$1,500 additional to start, with \$300,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$180,000 \$60,000 to third, \$30,000 to fourth, \$15,000 to fifth and \$6,000 to sixth. Supplemental nominations may be at time of entry at a fee of \$15,000, which includes entry and starting fees. Entries will be taken Sunday January 22, 2012. TIZ THE ARGUMENT set the pace along the inside into the far turn, then was fading when checked nearing the quarter pole. PERFECT EMBRACE bumped with SWEET REPENT at the start and was done early.
