All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Supplemental nominations may be at time of entry at a fee of \$7,500, which includes entry and s tarting fees. Entries will be taken Sunday January 22, 2012. Weight: 123 lbs: Non-winners of a Graded stakes at a mile or over on the turf since November 1, allowed 2 lbs.; A graded stakes at a mile or over since September 1, 4 lbs; \$60,000 at a mile or over since August 1, 6 lbs; Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 starters, with Also Eligibles. If more than (14) entries pass the entry box preference will be given to graded stakes win ners then highest turf earnings 2010-2012 earnings. Trophy to the winning owner. HOOH WHY reserved off the pace, raced four wide around the far turn, then rallied to be up late. ROMACACA chased the pace off the rail, rallied to gain a slim lead inside the eighth pole but couldn't resist the winner late. SPEAK EASY GAL set the pace along the rail to inside the eighth pole, then weakened. UNBRIDLED HUMOR stalked the pace, raced three wide around the far turn, advanced to loom a threat in midstretch but didn't do enough late. VENTANIA well placed while saving ground, lacked a rally. TRIP FOR A. J. unhurried early, moved into contention around the far turn but had no further response. ZAPPARITION raced three wide and failed to menace. ROMIN ROBIN raced four wide and was not a factor. ASKBUT I WON'TTELL allowed to settle, advanced to reach contention in the stretch, then tired in the final eighth.
