FOR FOUR YEAR OLDS AND UPWARD REGISTERED FLORIDA BREDS WITH THE FTBOA.** Free nomination by Saturday, January 14, 2012, \$1,500 to pass the entry box and \$750 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Supplemental nominations may be at time of entry at a fee of \$7,500, which includes entry and starting fees. Entries will be taken Sunday 22, 2012. Weight: 123 lbs: Non-winners of a Graded stakes at a mile or over on the turf since November 1, allowed 2 lbs.; A graded stakes at a mile or over since September 1, 4 lbs; \$60,000 at a mile or over since August 1, 6 lbs ; Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 starters, with Also Eligibles. If more than (14) entries pass the entry box preference will be given to graded stakes winners then highest turf earnings 2010-2012 earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 96 feet). (Clear 80)

The latter, stalked the pace along the inside, eased out in the stretch and finished willingly for the place while unable to catch the winner. BAD DEBT rated off the pace after being caught in tight at the start, angled out for the stretch run and closed to gain the show. LIVINGSTON STREET reserved off the pace, saved ground into the stretch and lacked a rally. TEAKS NORTH tracked the pace three wide into the stretch but had no response in the drive. ROMAN TIGER outrun after breaking poorly, saved ground to no avail. BELL BY THE RIDGE was not a factor. BECKHAM BEND stalked the winner off the rail to nearing the top of the stretch, then tired.
