FIVE IRON away without apparent mishap, sped off from the others, pilot atop with a firm grip on the reins, was sent off on a mission to

bottom out the field, laying down a rapid second fraction, had the others close in upon departing the backstretch, waited until turning for home before being asked for a response, gave it, protecting an ever-dwindling advantage to prove best. SUMMER FRONT unhurried in the two path,

swung five wide into the stretch, charged down the center of the course gaining ground readily, but had to settle for the place. TETRADRACHM hung out four wide on the opening bend, took the three path around the subsequent one, scurried into contention with a sustained run launched from near the three-eighths pole, flattened out leaving the furlong marker. SPEAKING OF WHICH (IRE) three wide on the opening turn, was closer to the rail thereafter, spun into the lane have already been asked for run, missed out on the show award. UNBRIDLED OCEAN vacated the rail midway down the backstretch, got tipped into the three path coming to the five-sixteenths pole, commenced the stretch slighter wider, mustered up a mild response. SKY BLAZER took the three path around the first turn, continued from off

the inside throughout, got swung six wide into upper stretch, made no impact. SWIFT WARRIOR struck the gate at the start, rode the rail, needed urging from the rider to close the gap on the loose leader during the run around the far turn, faltered. GHURAIR off to a sluggish beginning, was quickly placed along the inside route, rode it for slightly more than six furlongs, fanned outward until settling in the area of the eighth path by the end of the maneuver in upper stretch, lacked the needed response. MANIGHAR (FR) stalked the winner from afar being two wide, gave way. SEAL COVE saved ground to the five-sixteenths marker and tired.
