COALPORT settled between horses within striking distance, split rivals nearing the furlong marker, quickened once uncovered and was up in the final stride. TREND stalked the pace in hand, launched a bold bid four wide, edged clear a furlong out, fought on gamely but was denied. UTLEY was allowed to settle, commenced his bid circled six wide, kicked on well and was getting to the top two steadily. OL ARMY contended between horses, but weakened in the final furlong and faded. POSITIVE SIDE was forwardly placed along the inside, got through entering the stretch, loomed a danger with a furlong to run but failed to sustain the drive. DEPECHE CHAT chased three wide to the final furlong and faded. MELLOW FELLOW sped clear to set the pace, was collared between horses and wilted in the drive. LONESOME STREET was unhurried into stride, moved up four wide through the turn, but toiled to no avail through the lane.
