6 FURLONGS. (1.084) STAKES. Purse \$75,000 *FLORIDA STALLION DESERT VIXEN S. FOR FILLIES, TWO YEAR OLDS.* By subscription of \$2,500 each (Stallion) ; \$750 to pass the entry box and an additional \$750 to start July 20. The added money together with all nomination fees, eligibility payments, entry and starting fees to be divided - A approximately 12.5% of gross purse July 20 after distribution of Stallion Nominator and Breeders' Awards; Approximately 20.5% of gross purse August 24 after distribution of Stallion Nominator and Breeders' Awards; Approximately 66.5% of gross purse October 12 after distribution of Stallion Nominator and Breeders' Awards. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Stallion and Breeders' Awards to be distributed according to Florida Statute in effect on the date of the race. Weight: 118 lbs. A trophy will be presented to the winning Owner. Nominations for Stallions closed on February 15, 2009 with 107S tallion Nominations. (No Supplementary Nominations). Closed Friday, May 17, 2013 with 364 nominations. (Cloudy 86)

SCANDALOUS ACT set the pace along the inside into the stretch, then drew off when asked. HOLIDAY MAGIC stalked the pace along the rail, moved into the attending position in the stretch but was no match for the winner while holding the place. QUINNKAT reserved off the pace, angled out for the stretch run and couldn't keep pace with the winner while gaining the show. FANTASTIC VOYAGE unhurried after being steadied soon after the start, swung out for the stretch run and never threatened. IN LUV WITH WILLIE stalked the pace three wide into the stretch, then tired. GOLDEN FRIENDSHIPS tracked the pace, advanced four wide around the turn to reach the attending position at the quarter pole, then faltered. PROVERBS THIRTYONE showed brief speed and faded.
