By subscription of \$2,500 each (Stallion) \$3,500 to pass the entry box and \$3,500 additional to start. The added money together with all nomination fees, eligibility payments, entry and starting fees to be divided - Approximately 12.5% of gross purse August 8 after distribution of Stallion Nominator and Breeders' Awards; Approximately 20.5% of gross purse August 29 after distribution of Stallion Nominator and Breeders' Awards; Approximately 66.5% of gross purse October 17 after distribution of Stallion Nominator and Breeders' Awards. Purse to be divided 60% to first, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Stallion and Breeders' Awards to be distributed according to Florida Statute in effect on the date of the race. Weight: 120 lbs. A trophy will be presented to the winning Owner, Trainer and Jockey. Nominations for Stallions closed on February 15, 2006 with 140 Stallion Nominations. (No Supplementary Nominations). JACKSON BEND stumbled badly bumping WAVE ME BY at the start, moved up quickly to stalk the pace three wide, gained a slim lead just past midway of the far turn, then shook off a challenge from THANK U PHILIPPE in the stretch and edged away. THANK U PHILIPPE tracked the pace, eased out leaving the far turn, made a run at the winner in midstretch but couldn't stay with that rival while clearly best of the rest. BIM BAM chased the pace, made a run to gain a brief lead on the far turn, then tired. ALLEZ REEF reserved off the pace, faltered leaving the far turn. CHRISTOPHER'S IMAGE was no factor after being steadied from between rivals in the early going. WAVE ME BY was outrun after being bumped by JACKSON BEND at the start. CONCERT STAGE chased the pace along the rail for a half mile, then faded. WHAT A PRINCE set the pace into the far turn, then had nothing left.
