1 1/4 MILE. (Turf) (1:38) STAKES. Purse \$200,000 Ft. Lauderdale S.FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, January 1. \$1,500 to enter and \$500 to start. \$200,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over on turf since July 1 allowed 2 lbs.; a stakes race at a mile or over on turf since July 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off the turf, it may be subject to downgrading upon review of the GradedStakes Committee. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Sixteenth) (Rail at 48 feet). (Cloudy 74)

Bay Gelding, (Feb), by Flatter - Buttercup's Song by Unbridled's Song. Trainer Charles L. Dickey. Bred by B & B Thoroughbreds Inc. & Marty Hughes (KY).

FLATLINED was outrun two wide into the first turn, remained well back while saving ground into the far turn, angled off the rail sharply in upper stretch appearing to intimidate FIRE AWAY, split horses and was up in the final strides outside. ALMANAAR (GB) was reserved two to three wide early, went two wide on the far turn, found his best stride and surged between horses late and just missed. DIVISIDERO was washy going to post, trailed for nearly six furlongs while three to four wide, came five wide into the stretch and gained through the late stages while steadily drifting to near the outer railing. HEART TO HEART broke to a clear lead while initially removed from the rail, set the pace inside and came under more pressure from ROSE BRIER and DIAMOND BACHELOR through the middle fractions, continued to battle with ROSE BRIER on the far turn and into midstretch and weakened. ROSE BRIER chased HEART TO HEART three wide around the first turn, pressed the issue between horses through the middle stages, remained prominent to midstretch and was outkicked late. NIGHT PROWLER raced on the rail within striking range for six furlongs, eased out three wide for room approaching the stretch and was outkicked through the final eighth of a mile. LUKES ALLEY raced in the middle of the field while saving ground, loomed a threat attempting to get through inside HEART TO HEART and ROSE BRIER a furlong out, was forced to alter course outside those two and was outfinished. JAY GATSBY was outrun trailing for six furlongs, circled six wide nearing the stretch and was no factor. FIRE AWAY was well back and four wide early, came off the far turn three wide and shied away awkwardly from an angling-out FLATLINED in upper stretch, bumping with COPINGAWAY and getting his heels clipped by the latter. MACAGONE was in midpack three wide early, couldn't keep pace three to four wide on the far turn, brushed with COPINGAWAY while outside that rival and tiring in upper stretch. DIAMOND BACHELOR was outsprinted into the first turn while three to four wide, continued wide into the backstretch putting in a move to briefly join the leaders, began dropping back three wide around the far turn and was taken up behind the fallen horse in upper stretch. COPINGAWAY chased from fairly close range for six furlongs, was squeezed in upper stretch between MACAGONE and FIRE AWAY, clipped the heels of the latter and broke down.
