PRECIOUS KITTEN stalked the pace a bit off the rail, bid outside the runner-up into the stretch to gain the lead, was pushed along some to get clear and proved best under a steady hand ride while drifting out late. DIAMOND DIVA (GB) sped to the early lead, set the pace along the inside, could not match the winner in the stretch but was second best. RUTHERIENNE pulled a bit between horses then chased just off the rail, found the fence on the second turn, came out some in the stretch and bested the others. LAVENDER SKY also pulled a bit along the inside early, saved ground chasing the pace, continued inside in the stretch and did not rally. SOLVA (GB) tugged her way along outside rivals then alongside a foe chasing the pace, came out some in the stretch and lacked the needed response.
