Non-winners of a Grade 1 at a mile or over in 2009 allowed 3 lbs.; a Grade 1 or a Grade 2 at a mile or over, 5 lbs.; a Graded sweepstake at a mile or over in 2009, 7 lbs. Chestnut Filly, (Mar), by A.P. Indy - Morning Pride (IRE) by Machiavellian. Trainer bin Suroor Saeed. Bred by Gainsborough Farm LLC(KY).

FLASHING sprinted clear on the first turn, set the pace in hand for six furlongs, shook loose leaving the turn, extended her lead in upper stretch and drew away under steady right hand urging. UNRIVALED BELLE pressed the pace from outside for six furlongs, couldn't stay with the winner leaving the turn but continued on well to clearly best the others. BON JOVI GIRL was strung out four wide on the first turn, raced in the middle of the pack for five furlongs, closed the gap a bit while three wide on the turn and finished willingly to gain a share. MILWAUKEE APPEAL saved ground, moved between horses in upper stretch and lacked a strong closing response. STARDOM BOUND angled to the inside after breaking awkwardly, trailed early, moved out in hand along the backstretch, lodged a brief move on the turn and lacked a strong closing response. ME LOVE raced in hand along the rail, raced in good position while saving ground to the turn and tired in upper stretch. MULTIPASS failed to mount a serious rally. PEACH BREW stumbled at the start and was never close thereafter.
